TERMS & CONDITIONS OF BOOKING

Bookings - Full payment must be made with the booking and should be attached to the official booking form. A provisional booking can be made and a place will be held for 7 days whilst the booking form and payment are sent. After 7 days this place may be lost if the course is nearly full and other bookings with payment have been received.

Courses - It is the responsibility of the person booking the course to ensure they have booked the correct course. No refund will be given if the wrong course has been booked. Please see the attached prospectus for course details and pre-requisites.

Proof of identity & Credentials - The following items must have been presented to the tutor prior to the start of the course:

- One passport size photograph.
- Proof of identity (card type, driving licence or passport).
- A photocopy of the required qualifications (see prerequisites).

Important note: Where a candidate in unable to produce the above identification and documentation, Schiedel reserve the right to refuse entry to the course without refund.

Personal Protection - Candidates should bring with them safety boots, eye protection and safety gloves.

Methods of Payment - Cheque, Debit & Credit cards, BACS.
